## Schematic Layout Plan

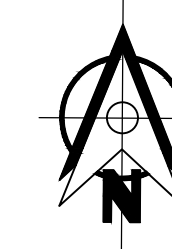

## AREA DESCRIPTION

- **Total Land Area** = **1076.704 Ha**  
*(as/survey plan dated 27/1/2023)*
- **Services & Common Facilities -**
  - Elec. Sub. Area (Nos.3) = 2.7 Ha
  - Fire & Police Station Area = 1.5 Ha
  - Water Treatment Plant = 4.0 Ha
  - STP and RWH = 3.0 Ha
  - Common Facility Centre = 4.5 Ha

Total Open Green Area shall be ensured as 33% of total land area (as/environmental clearance) including common open green as well as open green inside plots (as per Greater NOIDA Byelaws) while finalising the layout.
