The Financial Bid should be submitted online only in the BOQ Excel sheet. The documents received in physical form (hard copy) but not submitted online, shall not be accepted. Bid submitted without EMD shall be summarily rejected (except if exempted as per GeM provision).

The online bids can be submitted from the date of publishing the Tender on GeM Tender portal and till the Bid submission end date. The technical bids will be opened at **06:00 PM on Bid Submission end date in UPEIDA Office.**
