



Selection Process

1. After fulfilling the pre-qualification conditions of minimum 5 years experience and at least 05 Forest Clearance Approvals from MoEF&CC, the firm will be qualified for consideration.
2. The lowest financial proposal will be selected and the LoI will be awarded to that firm.
3. The selection will be done by a committee of UPEIDA before the bidders.
4. Financial Bid of only qualified bidders shall be opened. The decision of Chief Executive Officer, UPEIDA for selection of the agency shall be final and binding on the applicants.
5. The Financial Bid shall include all expenses to be incurred by the Applicant Firm inclusive of travel, manpower, stationary expenses, taxes etc. No additional payment other than Financial Bid shall be paid by the Authority.
6. Conditional bid shall be summarily rejected.
